RESOLUTION EARNESTLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY THROUGH THE OFFICE FOR TOURISM, CULTURE AND ARTS, TO ALLOCATE FUNDS INTENDED FOR THE APPRAISAL, STUDY, ASSESSMENT, CONSIDERATION AND DEVELOPMENT OF OTHER POTENTIAL TOURISM DESTINATIONS, COMMODITIES AND SERVICES ALL OVER THE CITY OF SORSOGON

WHEREAS, the tourism agenda of the city government of Sorsogon is one of the priority programs of the present administration of Hon. City mayor Ma. Ester E. Hamor labelled as “Gayon Sorsogon” with focus on the beauty of Sorsogon, its history, culture, people and destination;

WHEREAS, there are lot of places, local products and services all over the city of Sorsogon that have the tourism potential awaiting to be discovered;

WHEREAS, the city government shall source out marketing of the city’s tourism destinations, services and products and shall encourage and motivate local investment therein, thus, marketing and advertising supports by the city government shall be extended to them;

WHEREAS, appraisal, study, assessment, consideration and development of other potential tourism destinations, commodities and services all over the city of sorsogon could provide our local residents bigger and countless opportunities for living;

NOW THEREFORE, on motion of **Hon. Jo Abegail C. Dioneda**, duly seconded by **Hon. Mark Jayson D. Jamisola**, resolved as it is hereby resolve to earnestly request the Hon. Ma. Ester E.
