RESOLUTION RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY THROUGH THE CITY HEALTH OFFICE TO ALLOCATE FUNDS FOR THE PROCUREMENT OF MEDICINES INTENDED FOR PERSONS WITH MENTAL ILLNESS IN LINE WITH CITY ORDINANCE NO. 29, SERIES OF 2017

WHEREAS, number of our indigent constituents encountered difficulties in soliciting assistance for the procurement of medicines or for continuous medical maintenance of their mentally ill family members;

WHEREAS, keeping and caring a mentally ill in the family, affects the other needs of the family;

WHEREAS, mental health conditions refers to a neurologic or psychiatric condition characterized by the existence of a recognizable, clinically-significant disturbance in an individual's cognition, emotional regulation, or behaviour that reflects a genetic or acquired

dysfunction in the neurobiological, psychosocial, or developmental processes underlying mental functioning;

WHEREAS, City Ordinance No. 29, Series of 2017, otherwise known as the "Mental Health Care Ordinance of 2017" affirms the basic right of our constituents to Mental Health as well as the fundamental rights of people who require mental health services;

WHEREAS, the city, through City Ordinance No. 29-2017, commit to promote the well-being of its people by ensuring that mental health is valued, promoted and prevented and the mental health condition are treated and mental health care is made available to the public;

WHEREAS, Section 9 thereof provides that mental health services shall be developed and integrated into primary health care system at the community level wherein basic mental health services shall be made available at all Rural Health Units down to the Barangay level;

WHEREAS, premises considered, it is most respectfully requested that a certain appropriation be allocated for the immediate purchase of the medicines and continuous medical maintenance of individuals with mental illness in the city of Sorsogon;

NOW THEREFORE, on motion of Hon. Jo Abegail C. Dioneda, duly seconded by Hon. Mark Jayson D. Jamisola, resolved as it is hereby resolve to respectfully request the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City through the City Health Office to allocate funds for the procurement of medicines intended for persons with mental illness in line with City Ordinance No. 29, Series of 2017.

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.
