**RESOLUTION RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY THROUGH ENGR. ROEL D. DOMER, OIC-CITY ENGINEER, TO RELOCATE THE CITY MOTOR POOL TO ANY SAFER, MOST SUITABLE AND CONVENIENT AVAILABLE LOCATION IN THE CITY OF SORSOGON**

**WHEREAS**, the city motor pool is presently located at the vacant lot owned by the city government at Barangay Bibincahan, East District, Sorsogon City;

**WHEREAS**, the present location of the motor pool in Barangay Bibincahan is surrounded by residential lots wherein a considerable number of population therein inhabited the same place and the motor pool area is the main thoroughfare thereof being their accustomed and usual road-right of way;

**WHEREAS**, being surrounded by residential lots and located in the road-right of way, the city government of Sorsogon could not even establish and construct a perimeter fence thereof to ensure protection, security and safety of the city properties mostly motor vehicles and automobiles and the personnel working therein;

**WHEREAS**, there are also number of incidents of burglary and stealing of motor parts, accessories, equipment, tools and the likes, that were recorded and cigarette butts and empty bottles of alcohol drinks were likewise found inside the vehicles;

**WHEREAS**, the motor pool became a playground for the children in the said community wherein motor vehicles and automobiles subjects for repair works were physically severely damaged;

**NOW THEREFORE**, on motion of **Hon. Reynaldo C. Taladtad**, duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to respectfully request the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City through Engr. Roel D. Domer, OCI-City Engineer, to relocate the city motor pool to any safer, most suitable and convenient available location in the city of Sorsogon.
