RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE CITY GOVERNMENT OF SORSOGON AND THE ENERGY DEVELOPMENT CORPORATION (EDC) REPRESENTED BY MS. REGINA VICTORIA J. PASCUAL, VICE-PRESIDENT AND HEAD OF CORPORATE SUPPORT FUNCTIONS, FOR THE INSTALLATION, CO-LOCATION AND OPERATION OF VERY HIGH FREQUENCY REPEATER SYSTEM IN THE EXISTING RADIO TOWER OF EDC IN ITS BACMAN FACILITY LOCATED AT THE CAWAYAN RELAY STATION, BARANGAY BUCALBUCALAN, WEST DISTRICT, SORSOGON CITY.

WHEREAS, among the items deliberated during the August 9, 2022 Regular Session of the 8th City Council is the Committee Report Number 15, Series of 2022 of the Committee on Public Works & Infrastructure relative to the Transmittal No. 41, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable members of the Sangguniang Panlungsod thru the SP Secretary dated July 22, 2022, requesting for the passage of a Resolution authorizing the Local Chief Executive to enter into a Memorandum of Agreement (MOA) between the City Government of Sorsogon and Energy Development Corporation

(EDC) for the installation, co-location and operation of Very High Frequency Repeater system in the existing radio tower of EDC in its Bac-Man facility located at the Cawayan Relay Station, Barangay Bucalbucalan, West District, Sorsogon City;

WHEREAS, the City Risk Reduction and Management Office intends to strengthen and improve radio communications within the Sixty-Four (64) Barangays of Sorsogon City as part of its Disaster Risk Reduction Management Plan during calamities and emergency responses;

WHEREAS, the Energy Development Corporation (EDC) desires to help and extend support to CDRRMO through its Corporate Social Responsibilities Program as part of its mission to forge collaborative pathways for a decarbonized and regenerative future;

WHEREAS, that such endeavour is beneficial and will protect the general welfare of the local populace especially in times of calamities;

WHEREAS, attached to the letter is a copy of a draft Memorandum of Agreement (MOA) for further perusal of the 8th City Council;

NOW THEREFORE, on incidental motion of **Hon. Lester R. Lubiano**, duly seconded by **Hon. Danilo A. Deladia** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) between the City Government of Sorsogon and Energy Development Corporation (EDC) for the installation, co-location and operation of Very High Frequency Repeater system in the existing radio tower of EDC in its Bac-Man facility located at the Cawayan Relay Station, Barangay Bucalbucalan, West District, Sorsogon City;
