RESOLUTION RESPECTFULLY REQUESTING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY THROUGH THE CITY AGRICULTURAL SERVICES OFFICE TO ALLOCATE FUNDS INTENDED FOR THE REHABILITATION AND MAINTENANCE OF FISH SANCTUARY OFF SHORE OF BARANGAY PEÑAFRANCIA, WEST DISTRICT, SORSOGON CITY

WHEREAS, a fish sanctuary is considered as the designated area within a specific fishing ground wherein fishing and other forms of activities are prohibited purposely to prevent damage to the ecosystem of the area and to protect and conserve fish and other marine species within their marine habitat with economic and ecological importance;

**WHEREAS,** the fish sanctuary located off shore of Peñafrancia, West District of Sorsogon City was established by virtue of City Ordinance No. 14, Series of 2005 in cognizance with the mandate of RA 7160 and RA 8550, otherwise known as the Fisheries Code of 1998;

**WHEREAS,** resource and ecological assessment studies in Sorsogon Bay for the past decade translated fishery resource depletion to resource overfishing or overexploitation;

WHEREAS, funding requirement for the rehabilitation and maintenance of fish sanctuary off shore of Barangay Penafrancia, West District, Sorsogon City shall cover various components, such as information education campaigns, fish sanctuary resource assessment, installation and/or rehabilitation of markers, establishment of sanctuary guard posts, support facilities and services such as floating cottage/house, service boats and capability building and livelihood trainings;

**WHEREAS**, premises considered, rehabilitation and maintenance of fish sanctuary off shore of Barangay Peñafrancia, West District, Sorsogon City is of immediate concern that need to be addressed to;

**NOW, THEREFORE,** on motion of **Hon. Nestor J. Baldon**, duly seconded by the body, resolve, as it is hereby resolved to respectfully request Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City through the City Agricultural Services Office to allocate funds intended for the rehabilitation and maintenance of fish sanctuary off shore of Barangay Peñafrancia, West District, Sorsogon City.
