RESOLUTION MOST RESPECTFULLY REQUESTING THE PUBLIC EMPLOYMENT SERVICE OFFICE (PESO) FOR THE REGULAR WEEKLY POSTING AT THE BULLETIN BOARDS OF THE 64 BARANGAYS OF ALL JOB VACANCIES IN THE PUBLIC AND PRIVATE ESTABLISHMENTS IN THE CITY OF SORSOGON

WHEREAS, the Local Employment Generation Support Project of the Public Employment Service Office (PESO) aims to provide emergency employment opportunities to economically displaced individual;

WHEREAS, the Public Employment Service Office (PESO) further aims to provide programs for the enhancement of skills for self-employment through local initiative and/or counterpart scheme with stakeholders;

WHEREAS, the office is expected to have an available and updated list of job vacancies from employers and registry of skills to labor market clients;

WHEREAS, posting at the bulletin boards of the barangays, on a weekly and regular basis is one of employment strategies which brings together the employers and job seekers for immediate matching and employment purposes;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by the body, resolved as it is hereby resolve to pass a resolution respectfully requesting the Public Employment Service Office (PESO) for the regular weekly posting at the bulletin boards of the 64 barangays of all job vacancies in the public and private establishments in the City of Sorsogon.
