RESOLUTION RESPECTFULLY SUBMITTING TO THE SANGGUNIANG PANLALAWIGAN COMPLIANCE OF THE 8TH CITY COUNCIL IN RELATION TO SANGGUNIANG PANLALAWIGAN RESOLUTION NO. 11-2022 DATED JANUARY 03, 2022 DISAPPROVING CITY ORDINANCE NO. 20, SERIES OF 2021 AND FURTHER APPEALING FOR ITS CONSIDERATION AND APPROVAL.

WHEREAS, on January 03, 2022, the Sangguniang Panlalawigan passed and approved Resolution No. 11-2022 disapproving City Ordinance No. 20, series of 2021 of the 7th City Council of Sorsogon;

WHEREAS, said resolution from the Sangguniang Panlalawigan was communicated back to the Sangguniang Panlungsod with its findings;

WHEREAS, considering the matter to be crucial and part of the Ten Point Agenda of the present administration under the leadership of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, the 8th City Council respectfully submits the following documents believed to be

vital for the appeal for the reconsideration and approval of City Ordinance No. 20, series of 2021 as follows;

7. Photocopy of Extra Judicial Settlement of Estate with Special Power of Attorney executed by the Heirs of the late Bernabe J. Cadiz and Julita Zorilla-Cadiz with acknowledgement and authentication from various consulate;
