**RESOLUTION FAVORABLY ENDORSING TO THE CIVIL SERVICE COMMISSION EN BANC THE APPROVAL OF QUALIFICATION STANDARDS ENUMERATED UNDER THE CREATED CITY TRICYCLE FRANCHISING REGULATORY OFFICE OF THE CITY GOVERNMENT OF SORSOGON UNDER THE LEGISLATIVE DEPARTMENT IN CONSONANCE WITH RULE VIII OF 2017 OMNIBUS RULES AND APPOINTMENTS AND OTHER HUMAN RESOURCE ACTION (REVISED JULY 2018) PROMULGATED ON JULY 03, 2018).**

**WHEREAS**, tricycle franchise regulations is among the devolve functions to local government units pursuant to relevant provisions of Republic Act 7160 otherwise known as the Local Government Code of 1991;

**WHEREAS**, at present, the City Government of Sorsogon has more or less Four Thousand Five Hundred issued Tricycle Franchise operating in the territorial jurisdiction of city being the usual mode of transportation;

**WHEREAS**, as also provided in the relevant local legislation, issuance of Certificate of Tricycle Franchise is within the authority of the Sanggunian Panlungsod to regulate and provide existing policies;

**WHEREAS**, in the exigency of service and through an ordinance, there is a need to create the City Tricycle Franchise Regulatory Office;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 8<sup>th</sup> City Council deemed it necessary to pass a resolution favorably endorsing to the Civil Service Commission En Banc the approval of Qualification Standards enumerated under the created City Tricycle Franchising Regulatory Office of the City Government of Sorsogon under the legislative department in consonance with Rule VIII of 2017 Omnibus Rules and Appointments and Other Human Resource Action (Revised July 2018) promulgated on July 03, 2018);

**NOW THEREFORE**, on motion of **City Councilor Nestor J. Baldon**, duly seconded by **City Councilor Bryan J. Pingul** resolve as it is hereby resolve to favorably endorse to the Civil Service Commission En Banc the approval of Qualification Standards enumerated under the created City Tricycle Franchising Regulatory Office of the City Government of Sorsogon under the legislative department in consonance with Rule VIII of 2017 Omnibus Rules and Appointments and Other Human Resource Action (Revised July 2018) promulgated on July 03, 2018);
