**RESOLUTION RESPECTFULLY REQUESTING THE SIXTY FOUR (64) BARANGAYS TO IDENTIFY BARANGAY RESIDENTS WITH COMPLAINTS ON THE PRIME WATER OPERATIONS;**

**WHEREAS**, for several occasions, Prime Water Infrastructure Corporation and Sorsogon City Water District (SCWD) have been invited by the Sangguniang Panlungsod to shed light on various complaints brought before the august body to include the social media;

**WHEREAS**, following the relevant provisions of Republic Act 7160 otherwise known as the Local Government Code of 1991, the 8<sup>th</sup> City Council, as representatives of the people has the mandate to take necessary action in aid of legislation for purposes of protecting the general welfare of the public;

**WHEREAS**, for purposes of documentation, there is a need to identify barangay residents with complaints relative to operations Prime Water Infrastructure Corporation in the territorial jurisdiction of the City of Sorsogon;

**WHEREAS**, the collective complaints of barangay residents shall be officially endorsed by the 8<sup>th</sup> City Council to Prime Water Infrastructure Corporation and immediately appropriate action shall be sought in consonance with the 8<sup>th</sup> City Council's mandate to protect the interest of the general public;

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 8<sup>th</sup> City Council deemed it necessary to pass a resolution respectfully requesting the Sixty Four (64) Barangays to identify barangay residents with complaints on the Prime Water Operations;

**NOW THEREFORE**, on motion of **City Councilor Jo Abegail C. Dioneda** duly seconded by **City Councilor Glenn P. Olbes**, resolve as it is hereby resolved to respectfully request the Sixty Four (64) Barangays to identify barangay residents with complaints on the Prime Water Operations;

**RESOLVED FURTHER**, that the 8<sup>th</sup> City Council reserves the right to seek assistance from appropriate national government regulatory body in relation to failure of Prime Water Infrastructure Corporation to deliver its mandate to water consumers in the territorial jurisdiction of the City of Sorsogon;
