RESOLUTION RESPECTFULLY REQUESTING THE PRIME WATER INFRASTRUCTURE CORPORATION TO FURNISH THE 8TH CITY COUNCIL ACTIONS UNDERTAKEN IN RELATION TO THE COMPLAINTS OF WATER CONSUMERS IN THE TERRITORIAL JURISDICTION OF THE CITY OF SORSOGON.

WHEREAS, water is among the basic commodity and necessity which is critical in the daily routine of every individual;

WHEREAS, water utilities operating in every local government units are mandated to ensure ample potable water supply to its water consumers in compliance with relevant provisions imposed by appropriate national government regulatory bodies;

WHEREAS, at present, numerous complaints were brought before the 8th City Council and some were even posted in the social media expressing disgust and disappointment on the following issues;

1. Low to No Supply of Water for a long period of time;
2. Non Potable Water Supply evidenced by tea colored water emitting from residential faucets)

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution respectfully requesting the Prime Water Infrastructure Corporation to furnish the 8th City Council actions undertaken in relation to the complaints of water consumers in the territorial jurisdiction of the City of Sorsogon;
