RESOLUTION RESPECTFULLY REQUESTING SM PRIME HOLDINGS INC.-SM SORSOGON TO INITIATE AND ENCOURAGE ALL CONCERNED NATIONAL GOVERNMENT AGENCIES FOR THE ESTABLISHMENT OF GOVERNMENT SERVICE EXPRESS- A ONE-STOP SHOP FOR PAYMENT AND PROCESSING SERVICES WITHIN THE SM MALL LOCATED AT BARANGAY BALOGO, EAST DISTRICT, SORSOGON CITY

WHEREAS, Sorsogon City, the capital of Sorsogon Province, has a land area of 276.11 square kilometers or 106.61 square miles which constitutes 13.03% of the total province land area and its population as determined by the 2020 Census was 182,237, representing 21.99% of the total population of Sorsogon Province;

WHEREAS, being the capital of the Province of Sorsogon, the city is in its economic golden era, wherein despite of the Covid 19 Pandemic, number of business establishments are continuously coming up within and outside the Central Commercial District, such as malls,

restaurants/food outlets, service centers, shopping centers/outlets, product and service franchise outlets and other economic players;

WHEREAS, Sorsogon City is comprised of 64 barangays and the province of Sorsogon is comprised of 14 municipalities and a city;

WHEREAS, due to pandemic, the general public suffered substantial economic losses and opportunities that people can no longer spend additional money, time and effort for their transactions with the various government agencies which could be found elsewhere, somewhere and anywhere;

WHEREAS, the establishment Government Service Express in SM-Sorsogon could also extends its services to the nearby provinces Bicol and of Samar;
