RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO AND/OR EXECUTE A USUFRUCT AGREEMENT AND DEED OF DONATION PURSUANT TO THE “TAAS NOO, CIUDADANO AKO MASS HOUSING PROGRAM TO THE BENEFICIARIES OF THE HOUSING UNITS GRANTED BY THIS LOCAL GOVERNMENT TO HOMELESS AND UNDERPRIVILEGED FAMILIES UNDER THE HOUSING COMPONENT OF THE “10 POINT DEVELOPMENT AGENDA” OF THE CITY GOVERNMENT OF SORSOGON.

WHEREAS, among the items deliberated during the August 23, 2022 Regular Session of the 8th City Council is a letter from Atty. Cyril C. Oropesa, City Legal Officer addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City thru the SP Secretary dated August 22, 2022 urgently requesting for the passage of a Resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into and/or execute usufruct agreement and deed of donation pursuant to the “Taas noo, Ciudadano Ako Mass Housing Program to the beneficiaries of the

housing units granted by this Local Government to homeless and underprivileged families under the housing component of the “10 point development agenda” of the City Government of Sorsogon;

WHEREAS, the City Government of Sorsogon, under its “10 POINT DEVELOPMENT AGENDA”, has undertaken the constructions and granting of housing and lot units to underprivileged and homeless families within the administrative jurisdiction of this local government;

WHEREAS, resulting from the resolute intent of the City Government to vigorously implement the aforesaid program for the less fortunate and needy sectors in the city, various housing units have already been completed, and others, in due time, would be soon accomplished;

WHEREAS, it is imperative that the turn-over/granting of the housing units to their respective beneficiaries must be covered with a USUFRUCT AGREEMENT, that sets forth the terms and conditions, rules and obligations that should be duly abided with and observed by the beneficiaries concerned;

WHEREAS, attached to the letter is a copy of a draft USUFRUCT AGREEMENT for further perusal of the 8th City Council;

NOW THEREFORE, on incidental motion of **City Councilor Maria Theresa S. Gonzalez**, duly seconded by **City Councilor Nestor J. Baldon**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into and/or execute usufruct agreement and deed of donation pursuant to the “Taas noo, Ciudadano Ako Mass Housing Program to the beneficiaries of the housing units granted by this Local Government to homeless and underprivileged families under the housing component of the “10 point development agenda” of the City Government of Sorsogon;

RESOLVED FURTHER, that the USUFRUCT AGREEMENT and DEED OF DONATION entered into by parties herein mentioned shall be an integral part of this resolution and copies of the same be furnished to the Sangguniang Panlungsod for record and archive purposes;


RESOLVED FINALLY, that copies of this resolution be furnished to all concerned for their information and guidance.
