RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A TRIPARTITE MEMORANDUM OF AGREEMENT (MOA) WITH THE PROFESSIONAL REGULATION COMMISSION (PRC), REPRESENTED BY ITS DIRECTOR, MR. SHARO B. LO AND SM PRIME HOLDINGS, INC., REPRESENTED BY ITS PRESIDENT, MR. HANS T. SY RELATIVE TO THE ESTABLISHMENT OF A PRC SATELLITE OFFICE WITH SM CITY SORSOGON.

WHEREAS, among the items deliberated during the August 23, 2022 Regular Session of the 8th City Council is Transmittal No. 53, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary dated August 8, 2022 RE: Requests for the passage of a Resolution authorizing the Local Chief Executive to enter into a Tripartite Memorandum of Agreement (MOA) with the Professional Regulation Commission (PRC), represented by its Director, Mr. Sharo B. Lo and SM Prime Holdings, Inc., represented by its President, Mr. Hans T. Sy relative to the establishment of a PRC Satellite Office with SM City Sorsogon;

WHEREAS, PRC is empowered to perform any and all acts, enter into contracts, make such rules and regulations and issue such orders and other administrative issuance as may be necessary in the execution and implementation of its functions and the improvement of its services under Section 7, paragraph (b) of the Republic Act No.8981, otherwise known as the “PRC Modernization Act of 2000”;

WHEREAS, the PRC is in need of facilities accessible to the populace to help realize its mandate of bringing frontline services to its clients and address the challenge of providing convenience to the public by bringing its services closer to the Filipino people, in public or private entities who are voluntarily offering their spaces for free as a public service or civic duty;

WHEREAS, LGU Sorsogon, in its effort to provide government services to its constituents without the need of distant travel and incur traveling expenses has requested the PRC to establish an Offsite Service Center (OSC) within SM City Sorsogon;

WHEREAS, the SM is the owner and developer of a nationwide chain of multi-level, fully-integrated retail shopping, dining, leisure entertainment complexes commercially known as the “SM Supermalls” (the “Mall”), including the SM City Sorsogon;

WHEREAS, attached to the letter is a copy of a draft Tripartite Memorandum of Agreement (MOA) for further perusal of the 8th City Council;

NOW THEREFORE, on incidental motion of **City Councilor Nestor J. Baldon**, duly seconded by **City Councilor Ma. Teresa D. Perdigon** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Tripartite Memorandum of Agreement (MOA) with the Professional Regulation Commission (PRC) represented by its Director, Mr. Sharo B. Lo and SM Prime Holdings, Inc., represented by its President, Mr. Hans T. Sy relative to the establishment of a PRC Satellite Office with SM City Sorsogon;

RESOLVED FURTHER, that the Tripartite Memorandum of Agreement (MOA) entered into by parties herein mentioned shall be an integral part of this resolution and copies of the same be furnished to the Sangguniang Panlungsod for record and archive purposes;

RESOLVED FINALLY, that copies of this resolution be furnished to all concerned for their information and guidance.
