RESOLUTION INTERPOSING NO OBJECTION ON THE APPLICATION OF MR. RODOLFO L. BONETE, JR., CHAIRMAN, CAPUY BASUD MULTIPURPOSE COOPERATIVE, FOR A PORTABLE GASOLINE STATION AT CABAMUCO PREMISES, BARANGAY CAPUY, WEST DISTRICT, SORSOGON CITY.

WHEREAS, records from the Office of the secretary to the Sangguniang Panlungsod revealed that Mr. Rodolfo L. Bonete, Jr., Chairman, Capuy Basud Multipurpose Cooperative, has a pending request filed before the Sangguniang Panlungsod seeking for the passage of a resolution interposing no objection on his proposed business endeavor;

WHEREAS, during committee hearing conducted by the Committees on Trade, Commerce and Industry and Peace, Public Order and Safety, the applicant was instructed to comply with mandatory requirements imposed by appropriate local and national government agencies specifically:

- Permit to Operate (PTO) to be secured from the Department of Environment and Natural Resources (DENR) prior to the release of the Mayor's Permit;
- Certification from the Punong Barangay that the area applied for the aforementioned business endeavour has no existing neighbors
- Barangay Resolution from Barangay Council of Capuy interposing no objection on the proposed endeavour by CABAMUCO

WHEREAS, in consonance with the principle of free trade and in order to protect the interest of the general constituents against the dangers of “bote-bote system” of selling of petroleum products, the 8th City Council, through the Chairman’s Committee Report of the Committee on Trade, Commerce and Industry and Peace, Public Order and Safety of the 8th City Council, hereby adopts and approves the recommendation for the passage of a resolution interposing no objection for the aforementioned application;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution interposing no objection on the application of Mr. Rodolfo L. Bonete, Jr., Chairman, Capuy Basud Multipurpose Cooperative, to operate a Portable Gas Station at the CABAMUCO premises at Barangay Capuy, West District, Sorsogon City;

NOW THEREFORE, on incidental motion of **Hon. Peter Joseph J. Ravanilla**, duly seconded by **Hon. Bryan J. Pingul**, resolve as it is hereby resolved to interpose no objection on the application of Mr. Rodolfo L. Bonete, Jr., Chairman, Capuy Basud Multipurpose Cooperative to operate a Portable Gas at Station at the CABAMUCO premises at Barangay Capuy, West District, Sorsogon City;


RESOLVED FURTHER, that herein applicant shall comply all requirements as imposed by appropriate local and national government agencies in relation to the herein mentioned business endeavor;
