RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR-5) REPRESENTED BY DR. NELSON B. BIEN, OIC – REGIONAL DIRECTOR, RELATIVE TO THE IMPLEMENTATION OF BALIK SIGLA SA ILOG AT LAWA (BASIL) PROGRAM IN THE CITY OF SORSOGON.

WHEREAS, among the items deliberated during the August 09, 2022 Regular Session of the 8th City Council is Transmittal No. 44, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary dated July 26, 2022, requesting for the passage of a Resolution authorizing the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with the Bureau of Fisheries and Aquatic Resources (BFAR-5) represented by Dr. Nelson B. Bien, OIC – Regional Director, relative to the implementation of the Balik Sigla sa Ilog at Lawa (BASIL) Program in the City of Sorsogon;

WHEREAS, pursuant to the general welfare clause of Republic Act No. 7160 or the 1991 Local Government Code, the Local Government is mandated to enhance the right of the people to a balance ecology, to encourage and support the development and appropriate and self – reliant scientific and technological capabilities, to enhance economic prosperity and social justice, and to promote full employment among residents;

WHEREAS, the Government of the Republic of the Philippines, through BFAR, in collaboration with the Local Government Unit concerned, is implementing the “Balik Sigla sa Ilog at Lawa (BASIL) Program” which aims to rehabilitate/restore the physical conditions of lakes, rivers and reservoirs, enhance the fisheries and repopulate indigenous species in support of biodiversity conservation, poverty alleviation and food sufficiency;

WHEREAS, the BFAR implements the “Balik Sigla sa Ilog at Lawa” (BASIL) Program in Bicol Region in accordance with the Fisheries Office Order No. 038 Series of 2022: Amended Guidelines on the implementation of BASIL Program;

WHEREAS, the parties concerned willfully and jointly agree to extend full support and cooperation on conservation partners in the effective project implementation, management and conservation of fishery resources;

WHEREAS, attached to the letter is a copy of a draft Memorandum of Agreement (MOA) for further perusal of the 8th City Council;

NOW THEREFORE, on incidental motion of **Hon. Angelu Magda P. Ravanilla**, duly seconded by **Hon. Hon. Jo Abegail C. Dioneda**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Bureau of Fisheries and Aquatic Resources (BFAR-5) represented by Dr. Nelson B. Bien, OIC – Regional Director, relative to the implementation of the Balik Sigla sa Ilog at Lawa (BASIL) Program in the City of Sorsogon;

RESOLVED FURTHER, that the Memorandum of Agreement (MOA) entered into by parties herein mentioned shall be an integral part of this resolution and copies of the same be furnished to the Sangguniang Panlungsod for record and archive purposes;
