WHEREAS, the Department of the Interior and Local Government issued Memorandum Circular No. 2022-083, on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

WHEREAS, the **Bacon-Sorsogon-Sawanga Transport Service Cooperative (BASSAWTRASCO)**, through its Chairman, Ramon B.
