RESOLUTION URGING SORECO II MANAGEMENT NOT TO IMPLEMENT DISCONNECTION TO MEMBER CONSUMERS WITH VALID COMPLAINTS AND ERRONEOUS METER READINGS CONDUCTED BY ONE DAY METER READERS PENDING RESOLUTION OF THE COMPLAINTS.

WHEREAS, various complaints were brought before the Hon. Mark Eric C. Dioneda, City Vice Mayor and posted in the social media;

WHEREAS, as part of his mandate as elected representative of the local general populace representing the legislative department, aforementioned resolution was proposed as a matter of response or possible solution;

WHEREAS, following the issues and concerns discussed during the August 30, 2022 Regular Session wherein the City Vice Mayor opted to relinquish the chairmanship to a member of the 8th City Council for purposes of having a thorough discussion, this resolution intends to protect the interest of the Member Consumers of SORECO II especially the various complaints regarding erroneous meter readings conducted by Member Consumer's Owners Organization One Day Meter Readers;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 9th City Council deemed it necessary to pass a resolution urging SORECO II Management not to implement disconnection to Member Consumers with Valid Complaints and erroneous meter readings conducted by One Day Meter Readers pending resolution of the complaints;

NOW THEREFORE, on incidental motion of **Hon. Mark Eric C. Dioneda**, City Vice Mayor duly seconded by the **Hon. Danilo A. Deladia**, resolve as it is hereby resolved to urge SORECO II Management not to implement disconnection to Member Consumers with Valid Complaints and erroneous meter readings conducted by One Day Meter Readers pending resolution of the complaints;
