**RESOLUTION ADOPTING EXECUTIVE ORDER NO. 29, SERIES OF 2022 – AN ORDER RECONSTITUTING THE LOCAL PUBLIC TRANSPORT ROUTE PLANNING (LPTRP) TEAM OF THE CITY OF SORSOGON, DESIGNATING ITS MEMBERS AND DEFINING ITS FUNCTIONS**

**WHEREAS**, Hon. City Mayor Ma. Ester E. Hamor has issued Executive Order No. 29, Series of 2022 for the reconstitution of the Local Public Transport Route Planning (LPTRP) team of the City of Sorsogon, designating its members and defining its functions;

**WHEREAS**, Joint Memorandum Circular No. 001-2017 of the DILG and DOTr mandates thru the LTFRB nationwide to prepare and issue local ordinances concerning Local Public Transport Route Plan (LPTRP);

**WHEREAS**, the DILG in the exercise of its general supervision of LGUs may establish and prescribe rules, regulations and other issuances to ensure that locally issued ordinances, orders, rules, and regulations concerning public transportation conform with existing laws and jurisprudence related to public transportation, in accordance with DILG and DOTC Joint Memorandum Circular No. 1-2008, dated 10 September 2008, entitled Guidelines in the review of local ordinances, orders, rules and regulations concerning public transportation;

**WHEREAS**, Section 1 of EO No. 712-2008 directs the immediate review of existing orders, rules and regulations issued by the local government units concerning public transportation, including the grant of franchise to tricycles, establishment and operation of transport terminals, authority to issue traffic citation tickets and unilateral rerouting schemes of public utility vehicles and for other purposes;

**WHEREAS**, Department Order No. 2017-011 or the “Omnibus planning and identification of public road transportation services and franchise issuance”, states that the DOTr shall set guidelines, criteria and procedures for local public transport planning and help build local capacities to prepare Local Public Transport Route Plan (LPTRP);

**WHEREAS**, Section 1 of Executive Order No. 29, Series of 2022 provides that the Local Public Transport Route Planning (LPTRP) team of the city of Sorsogon, shall be composed of the following:
