RESOLUTION RESPECTFULLY AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE LANDBANK OF THE PHILIPPINES (LBP) RELATIVE TO THE ELECTRONIC PAYMENT INSTRUMENTS (TRANSACTION ACCOUNT) FOR JOB ORDER EMPLOYEES OF THE CITY GOVERNMENT OF SORSOGON

WHEREAS, the City Government of Sorsogon has continuously availed of LandBank's products and services such as ATM Payroll Servicing, maintenance of NTA deposit account, availment of loan facility on various infrastructure projects;

WHEREAS, the City Government of Sorsogon desires to avail of LandBank's products and services – Electronic Payment Instruments (Transaction Account) to be used for the expedient disbursement of salaries, reimbursements, allowances and other benefits of its Job Order employees;

HEREAS, the Land Bank has agreed to provide the service of issuance of the transaction for the Job Order employees of the Local Government Unit of Sorsogon City, subject to terms and conditions as maybe mutually agreed upon;

WHEREAS, transaction account is an electronic payment instrument that uses EMV contactless and magnetic stripe technology containing the transaction account data;

WHEREAS, the value associated with the card which can be accessed through ATMs and Point-of-Sale terminals and online application channels;

NOW, THEREFORE, on incidental motion of **Hon. Nestor J. Baldon**, duly seconded by the body, resolve, as it is hereby resolved to authorize Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the LandBank of the Philippines (LBP) relative to the electronic payment instruments (transaction account) for job order employees of the City Government of Sorsogon.
