RESOLUTION URGING SORECO II MANAGEMENT AND BOARD OF DIRECTORS TO IMMEDIATELY CALL FOR AN EMERGENCY GENERAL ASSEMBLY IN VIEW OF PERSISTENT AND VARIOUS COMPLAINTS THEREOF.

WHEREAS, the highest policy determining body of SORECO II is the General Assembly composed by SORECO II Member Consumers;

WHEREAS, plans, programs and projects to be initiated by SORECO II Management through its Board of Directors would require the knowledge, consent and approval of the General Assembly anchored on the premise that funds for its implementation comes from SORECO II Member Consumers;

WHEREAS, just recently, the legislative department invited the presence of SORECO II Management in a regular session to enlighten the august body on matters relating to various complaints of Member Consumers on their unprecedented increases in monthly billing statements and eventually uncover the hereunder issues which would require the call for an Emergency General Assembly;

1. The presence and utilization of Member Consumer Owner's Organization One Day Meter Readers which eventually give rise to questionable and/or erroneous meter readings on monthly billing statements of SORECO II member Consumers;
2. The practice and/or policy of requiring SORECO II Member Consumers to execute a Promissory Note without validation of questionable and/or erroneous Monthly Billing Statements initiated by Member Consumer Owner's Organization One Day Meter Readers;

WHEREAS, in fairness to SORECO II Management, the 8th City Council through a regular session openly requested that they be furnished with documents relevant to the preceding statements such as Minutes of the General Assembly, Attendance Sheet and other relevant documents that would support and justify the presence and utilization of member Consumer's Owner's Organization, however until this time no documents have been submitted before the august body clouting doubt to its very existence;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution urging SORECO II Management and Board of Directors to immediately call for an Emergency General Assembly in view of persistent and various complaints thereof;

NOW THEREFORE, on motion of **Hon. Mark Eric C. Dioneda** duly seconded by **Hon. Ma. Teresa D. Perdigon** resolve ads it is hereby resolved to urge SORECO II Management and Board of Directors to immediately call for an Emergency General Assembly in view of persistent and various complaints thereof;

RESOLVED FURTHER, that copies of this resolution be furnished to SORECO II Management, SORECO II Board of Directors and National Electrification Administration (NEA) with the information that the City Council intends to resolve the issue at hand judiciously through the call for an Emergency General Assembly.
