RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO OFFICIALLY TERMINATE THE MEMORANDUM OF AGREEMENT (MOA) GOVERNING THE ESTABLISHMENT, MAINTENANCE, OPERATION AND MANAGEMENT OF THE FORMER SORSOGON TERMINAL COMPLEX FOR PUBLIC UTILITY VEHICLES ENTERED INTO BY AND BETWEEN THE LKY DEVELOPMENT CORPORATION AND THE CITY GOVERNMENT OF SORSOGON

WHEREAS, the utter lack of a terminal for public transport facilities, as buses, jeepneys, mini-buses, vans, and the like, that used to incessantly resulted to congestion on the thoroughfares of the city and caused disorderliness particularly on main city roads, had urgently prompted the then administration of the late former City Mayor Leovic R. Dioneda, representing the City Government of Sorsogon, on 20th day of May 2009, to enter, by virtue of an authority of the Sangguniang Panlungsod, into a MEMORANDUM OF AGREEMENT (MOA) with the LKY DEVELOPMENT CORPORATION, being represented by its president WILBERT T. LEE;

WHEREAS, in gist, the subject MOA governs the construction, establishment, maintenance, management and operations of the SORSOGON CITY CENTRAL BUS TERMINAL by and under the auspices of the LKY DEVELOPMENT CORPORATION;

WHEREAS, corollary to, and in support of the subject MEMORANDUM OF AGREEMENT, the Sangguniang Panlungsod passed Resolution No. 100, Series of 2009 dated 07 April 2009, approving the terms of reference for the agreement involving the establishment, construction and operation of the former Sorsogon Central Bus Terminal;

WHEREAS, the City Government of Sorsogon, in resolute good faith, has faithfully and diligently observed, performed and complied with the provisions of the MOA, however, the LKY DEVELOPMENT CORPORATION, without due notice to the City Government of Sorsogon, unilaterally disposed of and sold to the SM PRIMEHOLDINGS INC. the land area where thereat was located then SORSOGON CITY CENTRAL BUS TERMINAL;

WHEREAS, premises considered and the subject property of the MOA, which is a portion of the total land area sold to the SM PRIMEHOLDINGS INC. is already being non-existent, it is therefore necessary on the part of the city government to officially terminate the same for all intent and purposes;

WHEREAS, the Sangguniang Panlungsod hereby left to the sound discretion of Executive Department to decide on what action/s they may institute for the purpose;

WHEREFORE, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Danilo A. Deladia**, resolved, as it is hereby done, to authorize Hon. Ma. Ester E. Hamor, City Mayor to officially terminate the Memorandum of Agreement (MOA) governing the establishment, maintenance, operation and management of the former Sorsogon Terminal Complex for public utility vehicles entered into by and between the LKY Development Corporation and the City Government of Sorsogon;
