**RESOLUTION URGING THE REGIONAL DIRECTOR VIRGILIO C. EDUARTE, CESO III OF THE DEPARTMENT OF PUBLIC WORKS & HIGHWAYS (DPWH), REGIONAL OFFICE V GOVERNMENT CENTER TO COMPEL THE TRC CONSTRUCTION COMPANY, CONTRACTOR OF THE PORTION OF BACON- MANITO ROAD TO FAST TRACK AND OBSERVE THE APPROPRIATE TIME FRAME FOR THE COMPLETION OF THE CONCRETING PROJECT.**

**WHEREAS**, opening and concreting of roads are among the major project endeavors being implemented by the national and local government units;

**WHEREAS**, as part of the identified infrastructure projects in the City of Sorsogon is the concreting of Bacon- Manito Road that provide easy access in the delivery of goods and services among local residents thereof;

**WHEREAS**, as observed, concreting of portion of the aforementioned area may have been earlier completed by TRC Construction Company, however, the same remains unfinished and may pose danger among road users especially this coming rainy season;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 8<sup>th</sup> City Council deemed it necessary to pass a resolution urging the Regional Director Virgilio C. Eduarte, CESO III of the Department of Public Works & Highways (DPWH) Regional Office No. V Government Center to compel the TRC Construction Company, contractor of the portion of Bacon Manito Road to fast track and observe the appropriate time frame for the completion of the concreting project;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Danilo A. Deladia**, resolve as it is hereby resolved to urge the Regional Director Virgilio C. Eduarte, CESO III of the Department of Public Works & Highways (DPWH) Regional Office No. V Government Center to compel the TRC Construction Company, contractor of the portion of Bacon Manito Road to fast track and observe the appropriate time frame for the completion of the concreting project
