RESOLUTION MOST RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR SORSOGON CITY THRU ENGR. JOELAN D. AGUIRRE, CITY BUILDING OFFICIAL TO CONDUCT REGULAR INSPECTION AND MONITORING OF LATERAL AND VERTICAL CONSTRUCTIONS WITHIN THE TERRITORIAL JURISDICTION OF SORSOGON CITY

WHEREAS, it is a common observation and complaints from concerned constituents relative to constructions of concrete fence and buildings within the territorial jurisdiction of Sorsogon City;

WHEREAS, it is noticeable in the erection of building that the corresponding permits thereof procured from the concerned City Official with the corresponding fees therefor were not posted in a conspicuous area at the construction site which also includes concrete fences;

WHEREAS, assuming that existing laws, rules and regulations were faithfully complied such as the payment of the required fees then the construction permits issued shall be posted to inform the public that there is compliance with the requirement imposed by the city government;

WHEREAS, in the alternative the failure to post the notice in the area shall be equated to non-compliance of the owner or builder who are liable to pay the penalties thereof. This practice likewise deprives the coffers of the city government of the fees being levied therefor.

NOW THEREFORE, on motion of **Hon. Bryan J. Pingul** duly seconded by Hon. Danilo A. Deladia, resolved as it is hereby resolve to most respectfully request the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City thru Engr. Joelan D. Aguirre, City Building Official to conduct regular inspection and monitoring of lateral and vertical constructions within the territorial jurisdiction of Sorsogon City.
