RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) RELATIVE TO THE SUCCESS AND SUSTAINABILITY OF THE “ ONE MILLION TREES, SORSOGON CHALLENGE” UNDER THE KALIKASAN PROGRAM OF THE PROVINCIAL GOVERNMENT WITH THE NATIONAL AGENCIES, PRIVATE LAND OWNERS, BARANGAYS, NON-GOVERNMENT ORGANIZATIONS AND THE PROVINCIAL GOVERNMENT OF SORSOGON

WHEREAS, among the items deliberated during the September 06, 2022 Regular Session of the 8th City Council is the Joint Committee Report No. 28, Series of 2022 of the Committee on Land Use, Urban Planning and Housing and the Committee on Environmental Protection relative to the Letter of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor thru the SP Secretary dated August 1, 2022, requesting for the passage of a Resolution authorizing the Local Chief Executive to enter into a Memorandum of Agreement (MOA) by and between the Provincial Government of Sorsogon, NGA's, Private Landowners, Barangays and NGO's relative to the “ One Million Trees, Sorsogon Challenge” under the Kalikasan Program of the Provincial Government;

WHEREAS, the City Government is set to intensify its reforestation program in line with the Kalikasan Program of the Provincial Government which aims to plant 1 million trees annually for the next three years;

WHEREAS, this entails an annual target of at least 150,000 seedlings every year for the City Government hence, priority planting areas includes private lands, government lands and forest lands;

WHEREAS, relative to this, Memorandum of Agreements will be needed to formalize partnerships with various institutions and private landowners and to delineate respective roles and responsibilities to ensure the success of the program;

NOW THEREFORE, on incidental motion of **Hon. Lester R. Lubiano** duly seconded by **Hon. Jo Abegail C. Dioneda**, resolved as it is hereby resolve to authorize the Local Chief Executive to enter into a Memorandum of Agreement (MOA) by and between the Provincial Government of Sorsogon, NGA's, Private Landowners, Barangays and NGO's relative to the " One Million Trees, Sorsogon Challenge" under the Kalikasan Program of the Provincial Government
