**RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ACCEPT THE DEED OF DONATION (DOD) OF VICENTE H. NICOLAS, RICARDO H. NICOLAS AND FERDINAND A. NICOLAS COVERING A PARCEL OF LAND CONSISTING AN AREA OF FOUR THOUSAND FOUR HUNDRED EIGHTY SEVEN SQUARE METERS (4, 487 SQ.M.) SITUATED AT SITIO BARIIS, BARANGAY CABID-AN, EAST DISTRICT, SORSOGON CITY.**

**WHEREAS**, among the items deliberated during the September 6, 2022 Regular Session of the 8<sup>th</sup> City Council is the Committee Report No. 027 of the Committee on Land Use, Urban Planning & Housing relative to the Transmittal No. 049, Series of 2022 from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City dated August 2, 2022 with attached copy of Deed of Donation (DOD), addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru Mr. Rovon E. Domasian, Secretary to the SP, respectfully requesting for the passage of a Resolution authorizing her to accept the Deed of Donation of Vicente H. Nicolas, Ricardo H. Nicolas and Ferdinand A. Nicolas covering a parcel of land consisting an area of Four Thousand Four Hundred Eighty Seven Square Meters (4,487) situated at Sitio Bariis, Barangay Cabid-an, East District, Sorsogon City;

**WHEREAS**, the subject parcel of land shall be utilized as a road right of way of the previous donation consisting of Ten Thousand square meters (10,000 sq.m) under Resolution No. 088, Series of 2022 passed by the 7<sup>th</sup> City Council, hence the decision to donate was made by the Donors as a manifestation of continues support to the programs and projects of the City Government which redounds to the benefit of the people;

**WHEREAS**, the DONEE is a government institution duly-organized and validly existing under the laws of the Republic of the Philippines and has the requisite corporate authority to accept donations and to enter into, perform and execute the Deed of Donation;

**WHEREAS**, attached to the letter is a copy of the draft Deed of Donation for further perusal of the 8<sup>th</sup> City Council;

**NOW THEREFORE**, on incidental motion of **Hon. Lester R. Lubiano**, duly seconded by **Hon. Nestor J. Baldon** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E.
