**RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ACCEPT THE DEED OF DONATION EXECUTED BY MS. CARMEN CHUA COVERING THREE (3) PARCELS OF LAND WITHIN THE STA. SCHOLASTICA SUBDIVISION LOCATED AT BARANGAY TUGOS, WEST DISTRICT, SORSOGON CITY**

**WHEREAS**, among the items deliberated during the September 6, 2022 Regular Session of the 8<sup>th</sup> City Council is the Committee Report No. 026, Series of 2022 of the Committee on Land Use, Urban Planning and Housing relative to the Transmittal No. 047, Series of 2022 from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City and the Members of the 8<sup>th</sup> City Council dated July 29, 2022 requesting judgement and wisdom in relation to the proposed Deed of Donation of Ms. Carmen Chua covering three (3) Parcels of land within the Sta. Scholastica Subdivision located at Barangay Tugos, West District, Sorsogon City;

**WHEREAS**, the said donation from Ms. Carmen Chua emanates from the Barangay Resolution of the Barangay Council of Tugos in 2020 requesting the Local Government Unit for

assistance relative to the concreting of the main pathway of the St. Scholastica Subdivision which however was not granted due to the land ownership;

**WHEREAS**, the aforementioned donation would justify the commencement of concreting of the area in response to the clamour of the affected residents thereof;

**WHEREAS**, the DONEE is a government institution duly-organized and validly existing under the laws of the Republic of the Philippines and has the requisite corporate authority to accept donations and to enter into, perform and execute the Deed of Donation;

**WHEREAS**, attached is the draft Deed of Acceptance for further perusal of the 8<sup>th</sup> City Council;

**NOW THEREFORE**, on incidental motion of **Hon. Lester R. Lubiano**, duly seconded by **Hon. Nestor J. Baldon** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to accept the Deed of Donation executed by Ms. Carmen Chua covering three (3) parcels of land within the Sta. Scholastica Subdivision located at Barangay Tugos, West District, Sorsogon City.
