RESOLUTION PROVIDING BLANKET AUTHORITY TO HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO AN AGREEMENT, CONTRACTS AND OTHER SIMILAR LEGAL UNDERTAKINGS BY AND BETWEEN THE PROVINCIAL GOVERNMENT OF SORSOGON IN RELATION TO THE ADOPTION, IMPLEMENTATION AND OPERATION OF THE 7K PROGRAM OF HON. JOSE EDWIN “BOBOY” B. HAMOR, GOVERNOR, PROVINCE OF SORSOGON

WHEREAS, the City Government of Sorsogon shall demonstrate leadership and commitment in the 7K Program of the Provincial Government through the leadership of Hon. Governor Jose Edwin B. Hamor in setting up quality objectives for all of its programs, projects and activities within the bounds of all applicable statutory and regulatory requirements;

WHEREAS, the 7K Program of the provincial government through the leadership of Hon. Governor Jose Edwin B. Hamor provides complete packed of programs, projects and activities supported with comprehensive strategies and dynamics to fully attain its purpose and objectives;

WHEREAS, the 7K Program stands for Kabuhayan, Katrangkilohan, Kalusugan, Kadunungan, Kagayunan, Kalinisan and Kalikasan;

WHEREAS, the City Government of Sorsogon shall adopt, sustain and strengthen the 7K Program within its jurisdiction to completely address the needs and aspirations of its constituents;
