**RESOLUTION RESPECTFULLY ENDORSING TO THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY THE ISSUES AND CONCERNS OF THE SORSOGON CITY EMPLOYEES UNION (SCEU) REGARDING THE CITY EMPLOYEES HOUSING PROGRAM PHASE II AND THEREBY REQUESTING TO FACILITATE AND ASSIST IN THE RESOLUTION OF THE SAME**

**WHEREAS**, one of the items deliberated upon by the 8<sup>th</sup> City Council on its Regular Session on September 13, 2022 under Other Matters, was the issue raised by the Hon. Nestor J. Baldon relative to the City Employees Housing Program Phase II which until this date is left unsettled;

**WHEREAS**, frequent inquiries seeking for answers from concerned members of the SCEU City Employees have been entertained by the Sangguniang Panlungsod;


