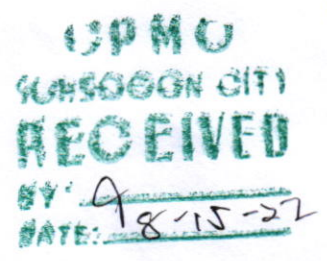
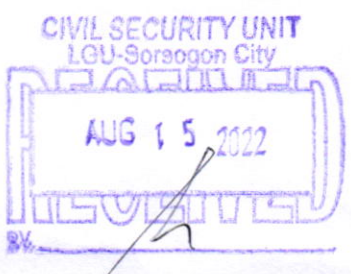

CONTRACT AGREEMENT

THIS AGREEMENT made this **5th** day of **August, 2022** between **Ma. Ester E. Hamor, City Mayor, City of Sorsogon** Philippines (hereinafter called the " Entity") of the one part and **RYAN BELLESA, Manager of DENVER COMPUTER SHOP, INC.** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **SUPPLY AND DELIVERY OF VARIOUS IT EQUIPMENT FOR CDRRMO** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Three Hundred Thirty Eight Thousand Nine Hundred Twenty One Pesos (P 338,921.00) Only** (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

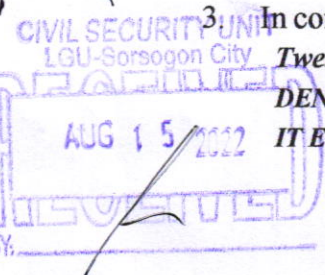
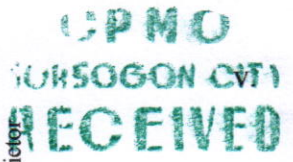
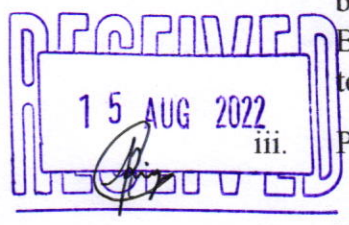
