## CONTRACT AGREEMENT

THIS AGREEMENT made this 6th day of May, 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and Maricel B. Binalingbing Authorized Representative of ALBAY COMPUTER & ELECTRONICS SUPPLIES AND REPAIR (hereinafter called the "Supplier") of the other part:

Performance Security;

iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

GPMO SOR50GON OF Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, that are subsequently required for submission after the contract execution, where the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
