## CONTRACT AGREEMENT

THIS AGREEMENT made this 1st day of August, 2022 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines ( hereinafter called the " Entity" ) of the one part and **DAISY TATEL SERILLA** Proprietor **GOSHEN CONSTRUCTION** ( hereinafter called the "Supplier" ) of the other part:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

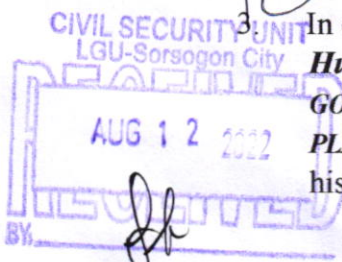
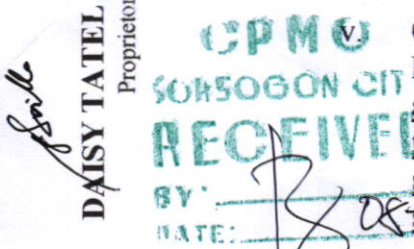
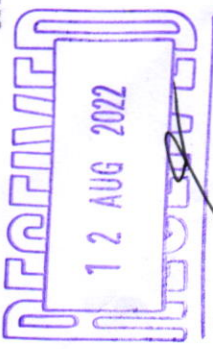
