CONTRACT AGREEMENT

THIS AGREEMENT made this 9th day of September , 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and DENNIS B. DURAN Jr. proprietor of AUTO-MOTO ZONE ENTERPRISES (hereinafter called the "Supplier") of the other part:
