Invitation to Bid REHABILITATION OF MULTI-PURPOSE BUILDING @ POBLACION BACON DIST CW 2022-11-074

- 1. The City Government of Sorsogon, through the Appropriation from the CEO-VARIOUS C.O intends to apply the sum of Eight Million Pesos (Php 8,000,000.00) Only being the Approved Budget for the Contract (ABC) to payments under the contract for **REHABILITATION OF MULTI-PURPOSE BUILDING** @ POBLACION BACON DIST. under Project Reference No. CW 2022-11-074. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *City Government of Sorsogon* now invites bids for the above Procurement Project. Completion of the Works is required *with in <u>120 calendar days</u>*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from *Bids and Awards Committee of the City Government of Sorsogon* and inspect the Bidding Documents at the address given below from 9:00A.M to 3:00 PM Only.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on *November* 29, 2022 from given address and website/s <u>sorsogoncity.gov.ph</u> and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of <u>Ten Thousand</u> (P 10,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
- 6. The *City Government of Sorsogon* will hold a Pre-Bid Conference¹ on *December 7*, 2022 @ 9:00am at *BAC Office*, *City Hall, Cabid-an, East District, Sorsogon City* which shall be open to prospective bidders however **SHALL** observed the Local Government Guidelines on COVID19 precautionary measures in relation to IATF protocol.
- 7. Bids must be duly received by the BAC Secretariat on *December 20, 2022* at 1:00 P.M through the authorized representative of the bidder who is also responsible in the observance of the health protocol . Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
- 9. Bid opening shall be on *December 20, 2022; 2:00 p.m.* at the given address below Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a prebid conference.

The *City Government of Sorsogon* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
