INVITATION TO BID

SUPPLY AND DELIVERY OF VARIOUS EQUIPMENT FOR USE IN THE DELIVERY OF QUALITY EDUCATION

GS 2022-11-069

1. The *City Government of Sorsogon* through the *Supplemental Appropriation in the Special Education Fund* intends to apply the sum of Three Million Eight Hundred Seventy Eight Thousand Two Hundred One (Php 3,878,201.00) Pesos being the ABC to payments under the contract for *the SUPPLY AND DELIVERY OF VARIOUS EQUIPMENT FOR USE IN THE DELIVERY OF QUALITY EDUCATION* under identification number **GS 2022-11-069**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *City Government of Sorsogon* now invites bids for the above Procurement Project. Delivery of the Goods is required by *within (30) Thirty Calendar Days*. Bidders should have completed, within (3) *Three years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II of the Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *the City Government Bids and Award Committee* and inspect the Bidding Documents at the address given below from *9:00 AM to 3:00PM only*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *November 28, 2022* from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand (Php 5,000.00) Pesos***. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *after payment has been made in person*.
6. The *City Government BAC* will hold a Pre-Bid Conference¹ on *December 5, 2022; 10AM* at *the BAC Office, City Hall, Cabid-an, East Dist. Sorsogon City for Pre-Bid Conference*, which shall be open to prospective bidders **however shall abide by the health protocol imposed by the Local Government unit as govern by the EO No. 22 of the Provincial Government of Sorsogon.**
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before *December 19, 2022 at 2:00 P.M.* Late bids shall not be accepted.

¹ May be deleted in case the ABC is less than One Million Pesos (Php1,000,000) where the Procuring Entity may not hold a Pre-Bid Conference.



8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on *December 19, 2022* at the given address below at 3:00 P.M. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *City Government of Sorsogon* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
