

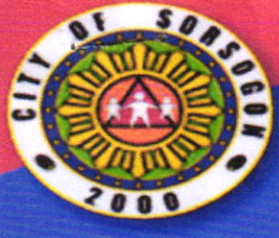

CONTRACT AGREEMENT

Contract No. 1296-2022 SVP

THIS AGREEMENT made this 1st day of August, 2022 between **Ma. Ester E. Hamor, City Mayor, City of Sorsogon** Philippines (hereinafter called the " Entity") of the one part and **JENNY VI. F. CANLAS** proprietor of **J. CANLAS AUTO PARTS** (hereinafter called the "Supplier") of the other part:


- iii. Performance Security;

4. The City Government of Sorsogon agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


