CONTRACT AGREEMENT

THIS AGREEMENT made this **9th** day of **September**, **2022** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the “ Entity”) of the one part and **AMIEL S. ENCELA** Proprietor of **A.E OFFICE AND SCHOOL SUPPLIES** (hereinafter called the “Supplier”) of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, **SUPPLY AND DELIVERY OF CLEANING TOOLS AND EQPMT FOR USE AT GAYON SOR. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **One Hundred Twenty Seven Thousand One Hundred Eighty Seven Pesos (P 127,187.00)** such other sums as may be ascertained, **A.E OFFICE AND SCHOOL SUPPLIES** agrees to viz **SUPPLY AND DELIVERY OF CLEANING TOOLS AND EQPMT FOR USE AT GAYON SOR. PROGRAM** in accordance with his/her/its Bid.





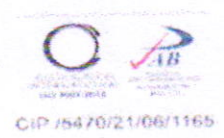
