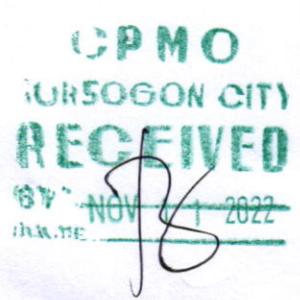
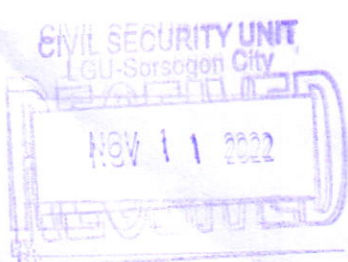

CONTRACT AGREEMENT

THIS AGREEMENT made this **28th** day of **October**, **2022** between **Ma. Ester E. - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

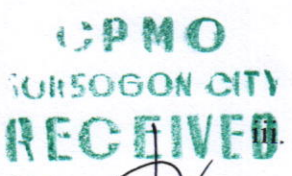

Notice of Award of Contract; and the Bidder's conforme thereto; and

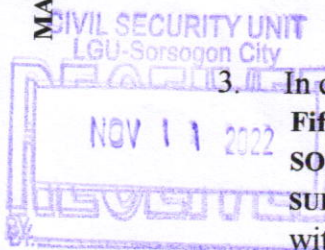


