## Contract Agreement No. B- 2022-029-GS

THIS AGREEMENT made this 7th day of November, 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and MS. EDEN D. DIG Proprietor of SUPER E ENTERPRISES (hereinafter called the "Supplier") of the other part:
