THIS AGREEMENT made this 6th day of December, 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and MS. ERLENA D. BENZON Proprietor of ERL PHARMA (hereinafter called the "Supplier") of the other part:
