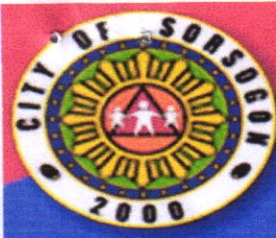

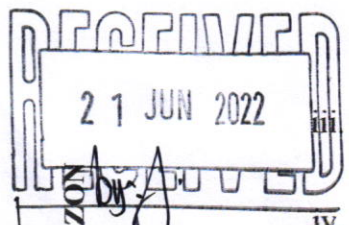

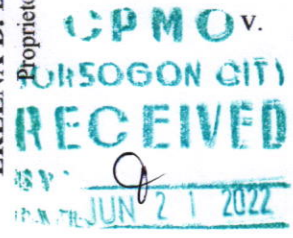

Notice of Award of Contract; and the Bidder’s conforme thereto; and

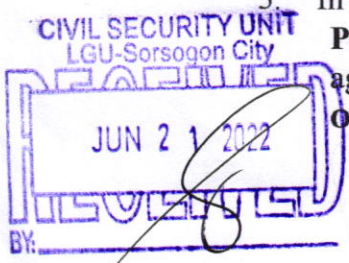

4. The City Government of Sorsogon agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






