





CONTRACT AGREEMENT

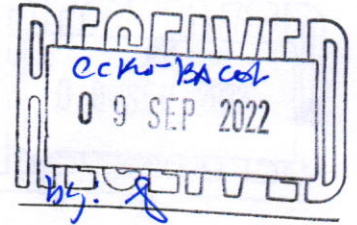
THIS AGREEMENT made this **2nd** day of **September**, 2022 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the “ Entity”) of the one part and **JOHN ANTHONY E. Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and

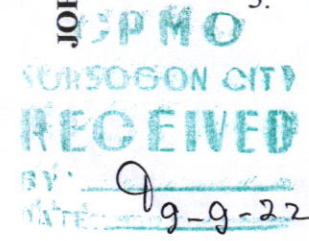
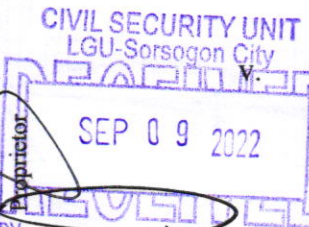

3. In consideration for the sum of **Sixty Three Thousand Pesos (Php 63,000.00)** or such other sums as may be ascertained, **UNA PIZZERIA** agrees to **PROCUREMENT OF CATERING SERVICES FOR THE SOLO PARENTS ORIENTATION** in accordance with his/her/its Bid.



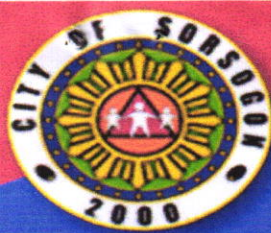
