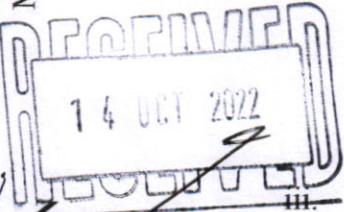

- iv. Notice of Award of Contract, and the Bidder's conforme thereto; and

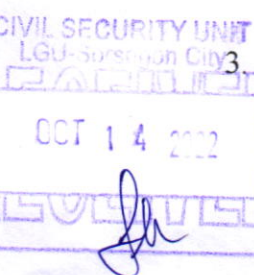
