

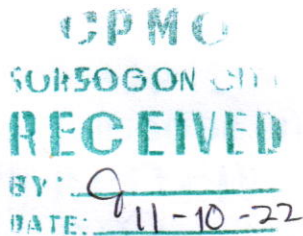

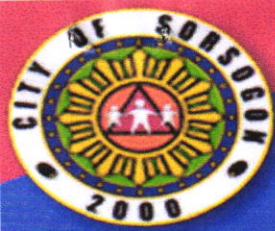

CONTRACT AGREEMENT

THIS AGREEMENT made this **2nd** day of **November**, 2022 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and **ALWAYNE DEAN MATEOS DELIGERO** Authorized Partner of **BLACKPAJAMA COMPANY** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **SUPPLY DELIVERY AND INSTALLATION OF NEW 2HP AIRCON AND DISMANTLING OF OLD ONE AT OCVM** during the State of Health Emergency and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **Fifty Eight Thousand Four Hundred Pesos (P 58,400.00) Only** (hereinafter called "the Contract Price").

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

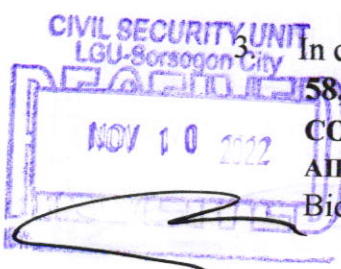
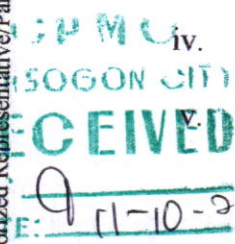

In consideration for the sum of **Fifty Eight Thousand Four Hundred Pesos (P 58,400.00) Only** or such other sums as may be ascertained, **BLACKPAJAMA COMPANY** agrees to viz **SUPPLY DELIVERY AND INSTALLATION OF NEW 2HP AIRCON AND DISMANTLING OF OLD ONE AT OCVM** in accordance with his/her/its Bid.





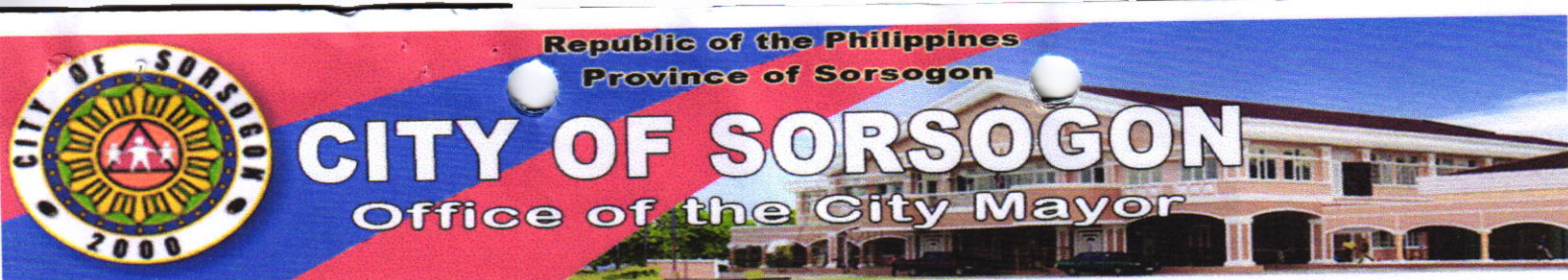
