

THIS AGREEMENT made this 12th day of December , 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and MS. MILAGROS D. LIAO Proprietor of BIG B ENTERPRISES (hereinafter called the "Supplier") of the other part:

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.</u>
- 3. In consideration for the sum of Three Million Nine Hundred Ninety Two Thousand Pesos (Php 3,992,000.00) Only or such other sums as may be ascertained, BIG B ENTERPRISES agrees to SUPPLY AND DELIVERY OF VARIOUS GOODS FOR THE 4TH QUARTER BUFFER STOCK in accordance with his/her/its Bid.


