





CONTRACT AGREEMENT

THIS AGREEMENT made this 4th day of November, 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and JUDITH M. DOLLISON Authorized Partner of WRITESHOP ENTERPRISES (hereinafter called the "Supplier") of the other part:
