CONTRACT AGREEMENT

THIS AGREEMENT made this **18th** day of **November**, **2022** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the " Entity") of the one part and **JUDITH M. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

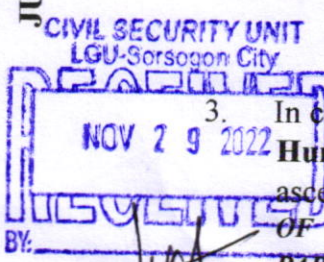
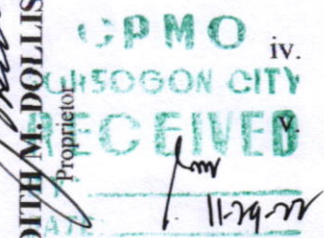
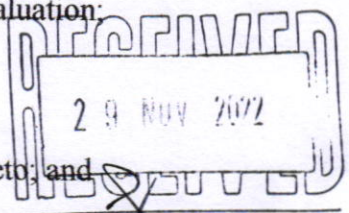

In consideration for the sum of **Seven Hundred Ninety Eight Thousand Eight Hundred Sixty Three Pesos (P 798,863.00)** or such other sums as may be ascertained, **WRITESHOP ENTERPRISES** agrees to viz **SUPPLY AND DELIVERY OF VARIOUS SPORTS SUPPLIES FOR USE OF THE CITY DEP-ED IN THE PARTICIPATION TO BICOL MEET** in accordance with his/her/its Bid.


