## **CONTRACT AGREEMENT**

THIS AGREEMENT made this 18th day of November , 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and MILAGROS D. LIAO Proprietor BIG B ENTERPRISES (hereinafter called the "Supplier") of the other part:
