

CONTRACT AGREEMENT

THIS AGREEMENT made this 25th day of November, 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and ROWENA MONTISOR LUNA Proprietor of OWN STYLE GRAPHICS DESIGN SERVICES (hereinafter called the "Supplier") of the other part:
