

## CONTRACT AGREEMENT

THIS AGREEMENT made this 12th day of December , 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and KATE A. DETERA Proprietor LIMA FOODS MARKETING (hereinafter called the "Supplier") ) of the other part:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;


