CONTRACT AGREEMENT

THIS AGREEMENT made this 7th day of November , 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and KEISUKE JAO NAKAMURA Proprietor KN ELECTRONICS ENTERPRISES (hereinafter called the "Supplier") of the other part:
